My signature, below, verifies that I will adhere to the code of conduct and agree to abide by the rules stated and on any official signage at the dog park. I understand the Park Plazas Dog Park Committee has the role to establish the rules, provide the access code to good standing members, acquire equipment/toys and hold an occasional fundraiser for any additional needs beyond the standard Park Plazas Dog Park budget allocation. I understand that the Dog Park Committee are volunteers; they will make every effort to notify members by email of any security code change made or pending, including the date and approximate time of the change.

I have read the dog park regulations and agree to abide by them.

- My signature indicates that I have read the following rules and will abide by all of them, or forfeit access to the key code.
- The Park Plazas Off-Leash Dog Park is for the exclusive use of Park Plazas residents and their guests.
- I understand there is an inherent risk with entering the dog park and participating in off leash play.
- Residents must accompany guests to the park.
- Dog Owners, or those having charge or custody of a dog, are legally responsible for their dogs and any injuries caused by their dogs. Dogs showing aggression toward people or other dogs must be immediately leashed and removed from the park.
- Dogs must maintain up-to-date rabies vaccinations and be registered in Santa Fe.
- Individuals must remain with their dogs, keep their dog in sight, and may not have more than 3 dogs they are monitoring in the park at any time.
- Dogs must be leashed before entering and upon leaving the dog park area. All dogs using the park must be spayed or neutered; no intact dogs allowed. (Logically, no female dogs in season). People must not allow their dogs to unduly disturb the terrain or vegetation.
- Professional dog trainers may not use the park for monetary purposes.
- Puppies under the age of 6 months are not allowed in the dog park.

- While food, treats and personal toys are permitted, they are not recommended. Use good judgement.
- Children under 12 are not allowed inside the off-leash dog park unless accompanied by an adult.

Dog Park Code of Conduct:

- No foul language will be tolerated, no smoking or recreational drugs. Please be kind to your neighbors.
- As a guest of a member in good standing of the Park Plazas neighborhood (no liens, all assessments paid); I pledge that I will clean up after my dog while in the dog park and on the walking trails.
- I will use the key code that gets changed on a regular basis and **NOT share this code** with anyone who isn't a HOA paying member in good standing. I will report any breakage of equipment to the PP manager in a prompt manner.
- If I have an aggressive dog (to either people or dogs) I will use the dog park when it is empty or take my dog to the lesser used 'small dog' area. I am responsible for my dog's behavior, and while minor skirmishes happen from time to time between even friendly dogs; if my dog were to create an unsafe environment, I will depart the park with my dog, and adjust my behavior accordingly. Further training and socialization may alleviate this problem in the future.
- If my dog is sick with diarrhea, I will not enter the dog park until the dog is well. If I find my dog is sick, while at the park, and later determine his condition is contagious, I will inform the dog park committee, so they can inform all other members of the park.
- If I bring a new dog to the park, I won't assume that he/she will get along with other dogs immediately. I will introduce him/her to the other dogs through the fence, utilizing the small dog park. (It is always advisable to introduce new dogs slowly whether at a new home or park). Once established that the nature of the dogs in the park are friendly and my dog responds in the same way, I can then enter the main dog park. (This is for the safety of everyone--nobody wants to have to break up a dog fight.).
- I will not prop open the gate, nor destroy the lock. I will not let strangers into the park; but direct them to the PPCSA office so they may sign the membership and rules form. I understand this is done for my protection as well as my neighbors.
- Dog equipment is for dog use only. No humans should attempt to crawl on any agility equipment with the exception of sitting on the concrete pipe.
- If I have a tenant, I will ensure they understand and abide by these same rules. I understand and will abide by these rules:
