# Karen Hyatt – Single Mom and Entrepreneur IVING THE GOOD LIFE IN PARK PLAZAS

In 1990, Karen Hyatt bought her townhome in Manzana Plaza from a friend who was leaving Santa Fe. Her son Max was 3. "It was the perfect place for both Max and me," Karen recalls at the start of our interview. "When Max got a little older, he could ride his bike on the paths and go to the playground. I always knew he was safe. We had neighbors who became friends — like the man who helped Max tie his tie as he was getting dressed for his first grade-school dance."

Smiling broadly, Karen reminisces about the "night walks" they would take when the moon was full. "Little boys talk more spontaneously when they are moving," she explains, "so once a month I'd let Max stay up late — and I would learn a lot about what he was thinking as we walked the paths in Park Plazas. Again, it always seemed safe, which was important for a single mother with a young son."

Born in Shawnee, OK, Karen earned her undergraduate degree in Radio/TV at the University of Oklahoma. She won a John D. Rockefeller III fellowship to learn arts administration in schools. Her fiancé had purchased an abstract company in Santa Fe, and Karen came here in

September 1979, after her fellowship ended. "It was wonderful," she remembers. "I worked in a gallery while I got my master's degree at UNM in Organizational Communication. I quickly realized that I love small-group and one-on-one communication. It's amazing what great ideas can come out of nothing in a small group."

In later years, after her marriage ended, Karen developed Chronic Fatigue Syndrome. As she recovered, she returned to academia, earning a second master's in Psychology from Pacifica Graduate Institute. She took a job hiring and managing caregivers for the last months of an elderly woman's life. "After she died, I visited her trust officer and offered to clean out her apartment and organize her possessions," Karen recalls. "In September 2010, I had that 'Aha!' moment. On Thanksgiving morning, I printed out homemade flyers about the business idea that would become Estate Pros. I took them around to


Phil Vergamini – Trad and True





ministers and bankers — and by January we had two contracts."

Karen continues: "I started Estate Pros with the goal of serving those who are left to deal with the often overwhelming responsibility of organizing and distributing what remains after someone dies. But within five months we were being asked to work on downsizing and relocation, especially as seniors moved into smaller spaces, including assisted living. In the larger picture, all of this downsizing work feeds into estate distribution."

Building her business hasn't been easy. "There were a lot of scary stretches," she says. "With a small company, you're lucky to be vertical in three years. But I

love what we do, and I'm grateful we've had such outstanding growth recently."

Today, Karen has 17 employees, eight in Santa Fe and nine in the Albuquerque area. Their territory ranges from Las Lunas to Taos. Everyone works part-time — except for Karen, of course. "As I always joke," she says, "death is inevitable but not predictable. It's been a challenge, but I've found team members who are OK with the way our business has to function."

When I ask about family, Karen mentions she's happy that her 87-year-old mother and her younger brother live nearby. Then, glowing with ulletpride, she tells me that son Max recently completed his J.D./M.B.A. at the University of San Francisco and is an associate with Baker McKenzie, one of the world's largest multi-national law firms.

He belonged initially to Bruce Papier, the retired professor and animal activist who championed our dog park. While Bruce lay dying from cancer, neighbors Andy and Petie Sildegs cared for Shorty and after Bruce passed away in August 2016, Karen adopted the dog. Or, as Karen notes, "Shorty adopted me."

"It was around Labor Day," she remembers. "As I sat on the couch with Andy nearby, Shorty jumped up and put his head in my lap. He had soulful eyes that locked onto mine. I basically knew it was meant to be. Shorty became part of the Estate Pros family, often going to job sites with us. In fact, he was at a big Tesuque estate, where I was working with a crew of five, on the day he died."

Sadly, Shorty began having full-out seizures after Karen returned home that October evening. "I rushed him to the emergency vet. I was sobbing, with tears running down my face," she says. "Shorty weighed 42 pounds, and he couldn't walk, but I managed to carry him in. It turned out to be a brain tumor — and the vet told me the damage was irreversible — so I made the decision to say goodbye. I'd had him for just over a year. It was devastating. I cried for two full days."

Soon, however, Karen was pretty much back to her warm, positive self. It's easy to see why clients appreciate her. (For more about Karen's business, including some impressive testimonials, link out to her website, estateprosnm.com.) As we wrap up our conversation, she reiterates: "Life is good."
